REGULATIONS

The final text of these Supplementary Regulations shall be the English version which will be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

Article 1 – Organisation

Article 5 - Insurances

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s):

Article 6 - Protests and Appeals

The protest fee is €1,000.

The international appeal fee (FIA) is \leq 6,000 (World RX) and \leq 3,000 (Euro RX).

All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the Competition, together with the required protest fee.

Competitors have the right to appeal, as laid down in Article 15 of the Code and also as set out in the Rules of the International Court of Appeal.

Article 7 - Event supplementary provisions

- a) The entry fee for a non-permanent Driver in World RX has been lowered to €3,000 for this event.
- b) The table of Article 15.5.5 of the Sporting regulations (World and Euro) is modified as below:

RALLYCROSS CHAMPIONSHIP

Article 8 - COVID-19 amendments

The Off-Road Commission and the stewards of the Competition have agreed to implement the following set of regulations for Safety reasons amid the Covid-19 crisis. This set of Regulations is overriding the current Sporting Regulations.

- **8.1.** Drivers and Competitors must commit to follow the instructions of the Appendix S to the ISC and of the latest release of the COVID 19 guidelines published by Promoter and to any additional local instruction brought by the organizer to comply with the local sanitary regulations.
- **8.2.** In case a Group is denied entry on the site of the event, the stewards will be notified. If this Group includes a Driver, they will be automatically considered as suspended until a negative test evidence is provided to the stewards.
- **8.3.** Administrative checks: Will be conducted by the Competitors Liaison Officer (CLO) through instant messaging system. Each Competitor will have to send photos of their Competitors' and Driver's licenses (front and back). The phone number of the CLO and the deadline to submit the information will feature in Part II of the Supplementary Regulations.

8.4. Scrutineering.

World RX: One mechanic wearing a face mask and gloves can be within the car working area when the FIA scrutineers approach the car.

Euro RX3: One mechanic wearing face mask and gloves must bring the car alone to the Scrutineering area when requested (as per Scrutineering Schedule in Part II of the Supplementary Regulations).

- **8.5.** The Team Managers' meeting and Drivers' Briefing will be conducted via a video conference link available in Part II of the Supplementary Regulations. Stewards will acknowledge the presence of Team Manager or Competitors and Drivers with the Zoom attendee panel. Penalties 20 or 26 under Article 17 of the Sporting Regulations will apply.
- **8.6.** Official Notice Board: The Official Notice Board will be exclusively Digital and can be found at the following address: https://www.fiaworldrallycross.com/onb
- **8.7.** The Competitors Liaison Officer (CLO) will be exclusively available through mobile phone or instant messaging. Each Competitor must declare their contact details during Administrative checks. Any protest, appeal or request towards the officials must be done through the CLO who will guide the Competitors to follow the correct sanitary procedures.
- **8.8.** Spotters' tower: There will be restrictions to the spotter's tower normal operations. Details of how and where spotters can work will provided at the Team Managers' Meeting and Drivers' Briefing.
- **8.9.** The podium procedure will be detailed at the Team Managers' Meeting and Drivers' Briefing.

8.10. Racecars going to the pre-grid can only be driven by their respective Drivers.
