The AP must have a circulation corridor delimited inside, with a single entrance and a single access exit in relation to the normal course of the event. The PA has installed, before the exit, a Refuel Zone properly signposted.

This report will constitute the official document supporting that decision.

Art. 12 - PROOFING THE COMPETITION

12.1 - Official time throughout the race - throughout the race, the official time will be the Portuguese GPS (GMT+1)

12.2 - Selective Sectors - in accordance with Art. 21 of the PETT.

12.2.1 - Maximum times - 15 minutes for the Prologue, 180 minutes for each of SS1 and SS2.

12.3 - Official Itinerary - itinerary book in accordance with Art. 11 of the PETT

12.4 - **Analysis of possible deviations or shortcuts** - The Race Director may use the GPS/GSM System. The report of the route covered by each team, as reproduced by the GPS/GSM System, will be made available to the race director, who will have to inform the CCD, who may apply the penalties provided in the table below. This report will constitute the official document supporting this decision. In accordance with Art. 11.2 of the PETT

1st infraction	15 minutes
2nd infraction	45 minutes

12.5 – Entry by advance is allowed without incurring any type of penalty, according to Art. 19.3 of the PETT, in the CHC at the end of the Prologue (1E) and in the CHC at the end of the two stages (2E and 3E).

12.6 - Rally 2-A competing team that has not completed the stage is allowed to proceed to the next stage, unless it confirms otherwise in writing to the DP. This provision applies to all teams not classified for having exceeded the maximum time limit, or for having missed a control. It will not apply, however, if the team has been disqualified due to one of the following reasons: having committed an infraction, having violated the traffic rules, not meeting the entry requirements for the event or by decision of the CCD, according to Art. 2.19 of the PETT.

Art. 14 - ALLOWED VEHICLES

14.1 - According to the regulation(s) of the championship/cup/trophy/series/challenge or criteria defined in Art. 1.2.1.

14.2 - In the UMM TUCHA DESAFIO, all UMM brand vehicles are admitted, including "prototypes". Vehicles that comply with the Ex-UMM Trophy Approval Form will be registered in the TO Group, integrated into the TPTT.

Vehicles in this Challenge that do not meet the specifications and do not conform to the Ex-UMM Trophy Approval Form are included in the T8 Group of the TPTT.

Art. 15 - SAFETY OF DRIVERS AND VEHICLES

15.1 - Vehicle equipment - according to the TT Technical Regulation.

15.2 - Drivers' equipment - the safety equipment of competing teams, will be controlled in accordance with Art. 11 of the PGAK.

Art. 16 - COMPLAINTS - APPEALS

16.1 - In accordance with Articles 14 of the PGAK and 13 and 15 of the CDI, respectively.

Art. 17 - CLASSIFICATIONS

17.1 - The classifications will be established in accordance with Art. 24 of the PETT.


