## REGULATIONS

The final text of these Supplementary Regulation shall be the English version, which will be used, should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

### ARTICLE 1 - ORGANISATION

The competition shall be run in accordance with the FIA International Sporting Code (ISC) and its appendices, the FIA and CIK-FIA official bulletins, the General Prescriptions applicable to the CIK-FIA Karting international Competitions, the CIK-FIA Technical Regulations, (Chapter 2 of the International Karting Regulations), the Event Sporting Regulations, The Event Technical Regulations, these Supplementary Regulations and CIK-FIA International Karting License for Drivers and Code of Driving Conduct. All entered Entrants and Drivers shall be holders of International Drivers licence & Entrant Licenses issued by CIK-FIA members ASN's and valid visa. Entrants licence may not be delivered to persons who are still underage and do not have full legal capacity.

**A.** Petrol is supplied by PANTA FUEL (and is compulsory to use)

**B.** Mixing Oil must be CIK-FIA Agreed lubricants in the current approval list.

**C.** No other liquids are allowed to mix in the petrol

## **ARTICLE 8 SUPPLEMENTARY CONDITIONS**

**8.1** From Thursday to Sunday vehicles will only have access to the Paddock in the morning to 8.45 after this time paddock gates will be closed to after the action on the track, it is forbidden to drive in the Paddock with any Car, Van or Lorry without a proven Promotors pass, even when the gate is open and not manually guarded, A fine will be inflicted by the Stewards on any person not respecting this rule

**8.2** Personal passes must be presented at any time and no one will be readmitted in SERVICING PARK, or PADDOCK - AREA without one. Personal passes that are not worn by their holders will be confiscated. Lost passes will not be replaced by the Organise or a fee of 70.00€ are to be payed. Vehicle passes are only valid if they bear the registration number of the vehicle
