ARTICLE 7 SUPPLEMENTARY CONDITIONS

1. From Wednesday to Sunday vehicles will only have access to the Paddock in the morning to 09:00 after this time paddock gates will be closed to after the action on the track, it is forbidden to drive in the Paddock with any Car, Van or Lorry without a proven Promotors pass, even when the gate is open and not manually guarded, A fine will be inflicted by the Stewards on any person not respecting this rule

2. Personal passes must be presented at any time, and no one will be readmitted in SERVICING PARK, or PADDOCK - AREA. Personal passes that are not worn by their holders will be confiscated. Lost passes will not be replaced by the Organiser or a fee of 70.00€ are to be paid. Vehicle passes are only valid if they bear the registration number of the vehicle.
