## Art.4 – VEHICLES ALLOWED AND SAFETY EQUIPMENT

#### 4.1 - Allowed modifications

It allowed an assembly of protection under each vehicle.

- **4.2 Eligible vehicles** They will be the ones that are closest to the homologation sheet at the moment, whose components, such as brakes, gearboxes and engines are the equivalents.
- **4.2.1** –All vehicles will be considered eligible according to the respective category in which they fit will be admitted.
- **4.2.2** Vehicles of Group B (authorized by FIA), included in the HISTORIC category.
- **4.2.3** WRC cars/ until 2005, included in the SPIRIT category.
- **4.2.4** Group B cars (FIA excluded and WRC after the year 2005), included in the category LEGEND SHOW without classification.
- **4.3** The vehicles will be divided according to the following DIVISION and CLASS:

## 4.3.1 - HISTORIC (Until 31st December 1986)

All vehicles that have taken part in competitions in the past, keep their body parts according to their homologation document, having the safety equipment demanded and updated according to the regulation in law and driver's equipment, as stated in arte 11.2 of the PGAK.

#### 4.3.2 - SPIRIT (from 1st January 1987 until 31st December 2010)

All vehicles that have taken part in competitions in the past, keep their body parts according to their homologation document, having the safety equipment demanded and updated according to the regulation in law, and driver's equipment as stated in arte 11.2 of the PGAK.

4.3.2.1 - Vehicles with FIA homologation (Car, Super1600 e WRC).

## 4.3.3 - LEGEND SHOW

4.3.3.1 – Cars with FIA homologation (Kit-Car, Super1600 and WRC), Group B (FIA excluded).

## 4.3.4 - LEGEND OPEN

**4.3.4.1** - All vehicles (altered) despite having historic bodies and other mechanical equipment (suspension, gearboxes, brakes, engine, and others) do not comply with the homologation form of the original vehicles, having only all the required and updated safety equipment in accordance with the regulations in force, pilot equipment according to article 11.2 of the PGAK.

#### 4.3.5 - For ALL Categories

- **4.3.5.1 The use of slick tyres isn't allowed** according to the Art. 13.3 of the PER.
- 4.3.5.2 It is allowed the use of Moulds tyres (shaped) according to the Art. 13.7 of the PER.
- **4.3.5.3** Automatic extinction (installed system) is mandatory for all vehicles built from 1<sup>st</sup> January 1986 and strongly recommended for all the other vehicles, with access to the outside.

#### 4.4 - SAFETY OF THE DRIVERS AND VEHICLES

#### 4.4.1 - Vehicles equipment

- All vehicles must be according to Art. 11.1 of the PGAK
- 4.4.2 Driver's equipment will be controlled according to Art. 11.2 of the PGAK.

## Art. 5 - ENTRY PROCEDURE

- 5.1 All competitors should send their applications according to the Art. 5.1 of the PER 2024
- **5.2** The applications will be made according to the Arts. 9.3 and 9.3.1 of the PGAK from the publication of this supplementary regulation on the web page of FPAK, until 06:00pm on October 11, 2024. To benefit from the discount, registration must be made by 06:00pm on October 4, 2024.

#### 5.3 - Required license

Historic, Spirit and Legend Show and Open / Portuguese competitors – Nacional licence C or above

**Historic, Spirit and Legend Show and Open / International competitors –** International licence or ASN licence that matches the national FPAK, with the authorized "Start Permission" to be locally issued.

## 5.4 - Maximum number of entries - 80 (Eighty)

#### Important information

The applications should be duly filled in in every required field. If it isn't properly filled in, the application may not be accepted.

## Along with the registration, you must upload a copy of the documents listed below:

- a) Driver and co-driver identification.
- b) Driver and co-driver driving licences.
- c) Sports licence of the driver and co-drivers
- d) All documents regarding the vehicle (Logbook, ownership vehicle, technical passport, homologation document, insurance, etc)
- e) In case the vehicle is registered in another name which is not the driver or co-driver, it will be necessary a notarized document, authorising the use of the vehicle.
- f) Car Insurance document
- g) Photos of the vehicle competing





## Art. 10 - COURSE DETAILS

- **10.1 Special stage classification –** according to Art. 20 of the PER (FPAK Rally Specific Prescriptions).
- **10.1.1 SS 1** according to Art. 21 of the PER (FPAK Rally Specific Prescriptions).
- **10.2 Official hour during the entire competition:** will be the GPS hour- the official Portuguese Hour.
- 10.3 Start vehicles admitted to the start of the 1<sup>st</sup> stage must enter the Starting Park, as defined in the Schedule. Any delay will be penalized by €100.

## 10.4 – Starting Order

- 10.4.1 the start for all classifying Special Stages will be given with an interval of a minute and by light in the start clock, being:
  - **RED** Stop
  - GREEN Start
- **10.4.2** The start for each section will be given in ascending order of numbers. Every vehicle eligible to start the 1<sup>st</sup> LEG <u>must</u> go to the Starting Park Promenade da Avenida Sá Carneiro (entre o CR7 e Beerhouse) between **04:45pm and 05:15 pm on the day 15<sup>th</sup> November 2024.** A map with the time for the start will be given, as well as published on the official board.
- 10.5 The results will be made by the company ANUBE, which will be responsible for the results, together with the control teams.

## 10.6 – Time Controls (entry by advance/delay)

At controls **TC1C**, **TC1D**, **TC9C**, **TC9D**, **TC12C** and **TC12D** teams can control by advance without incurring any penalty.

At the **TC0B and TC12D** controls, competitors can check in late without incurring any penalty.

## 10.7 - SLALOM STAGE

- **10.7.1** The Slalom stage show will be held on the 17<sup>th</sup> of November, starting at 03:00 pm (time for the first competitor).
- **10.7.2** This competition. is **NOT mandatory and will NOT count towards the Final Classification.**

**10.7.3** – The Special Stage show course will be handed to all competitors (map). There will be penalties for the competitors who do not follow the course, as well as any other situations. The penalties will be explained while handling the material.

#### RECONHECIMENTOS

O GPS será colocado com velcro no painel (A) ou no vidro frontal (B).

## RECONNAISSANCE

The GPS must be placed using velcro strips on the dashboard (A) or on the front glass (B).

At the start of the section, GPS beeps and shows on the screen the maximum speed limit allowed.

If this speed is exceeded, the device beeps several times and the LEDs flash with the maximum speed.

At the end of the section, it emits a beep and turns off the maximum speed of the LED screen.

#### IMPORTANT:

The Car / SSV must be presented at scrutineering with the bracket, cabling and antennas mounted, ready to receive the STELLA 3

#### KIT COMPOSITION:

- 4. RF and GPS antenna
- 5. Sticker



Bracket must be installed on the dashboard or panel, stella 3 bottons  $\underline{\text{must}}$  be visible and accessible by the rider in case of emergency.

It is mandatory to leave the cables with at least 15 cm of clearance for later connections.



Connect RED wire to +12v and GREY wire to negative It must be connected directly to the battery (no breaker and no contact on power)
We recommend to install a 3A fuse (not included) Then, bring power connector close to bracket.

#### 3. ANTENNAS: RADIO / GPS FREQUENCY

The antennas must be installed in vehicle roof.
It is strongly advised to place plastic collars and tape to maintain the antennas. They must be installed clear of all metal o carbon fiber obstacles.

## FREQUENCY USE LICENCE

The use of any radio electric sender/receiver equipment demands a previous ANACOM authorization.


To get such authorization should be previously informed:

- Brand, model and serial number of the equipment (homologation certificate number)
- Number of equipment to be used and the type of net function (VHF/UHF)
- Frequency (Mhz)
- Power of each equipment
- Installation position and antenna used (including its function)
- The amount of time to be used.

All equipment should operate with space between the consecutive channels 12,5 kHz.

THE REQUESTS SHOULD BE SENT TO ANACOM WITHIN A MINIMUM OF 15 WORKING DAYS BEFORE THEIR USE. THE REQUESTS WITH LESS THAN 15 WORKING DAYS HAVE AN EXTRA FEE FOR EMERGENCY

#### PARK FERMÉ

#### Location of the Park fermé

Regrouping – Platform Cais 8 of the Port of Funchal, Prazeres Supply Market (Calheta) and Quinta do Furão (Santana)

#### STARTING PARK FERMÉ

All competitors' vehicles admitted to the start of the 1st Leg/1st Section must enter the Pre-Start Park, located on the Avenida Dr. Sá Carneiro Promenade (between CR7 and Beerhouse), between 04:45pm and 05:15pm on Friday 15<sup>th</sup> November. A map with the respective entry time will be handed out and published on the official board.

Any delay will be penalised with a fine of €100.00 for the first five minutes of delay and €50.00 for each minute or fraction of a minute thereafter.

#### **SERVICE PARK**

There is one Service Park for the entire Rally. The Service Park is located on the platform at Pier 8 in the Port of Funchal.

## Access times for service vehicles - Platform Pier 8:

Friday, 15<sup>th</sup> November - from **02:00pm to 04:00pm** (Time to mounting the park) Saturday, 16<sup>th</sup> November - **08:00am to 09:00am** Sunday, 17<sup>th</sup> November - **07:00am to 08:00am** 

In the Service Parks, it is compulsory to use ground protection, which must cover the entire service area of the racing car and must be made of waterproof material. Failure to use this protection will result in payment of a fee of between € 2.500,00 and € 5.000,00, so that the organisation can provide this material.

The Service Park must be completely free and clear by 10:00pm on Sunday 17<sup>th</sup> November.

#### **APPENDIX - OTHER MATTERS OF INTEREST**

#### i. Timecards

The timecard will be given to each Competitor at: a) Rally start for Stage 1 and start for Stage 2.

#### ii. False Start

False starts will be penalized as follows:

- a) 1st offence 10"
- b) 2nd offence 1'
- c) 3rd offence 3'
- d) Subsequent offences. At the discretion of the Stewards

These penalties do not prevent Stewards from applying higher sanctions if they deem it necessary.

## iii. Recording traffic offences

During the Rally, competing teams must comply with the rules of the Portuguese Highway Code.

Code. Any competing team that breaks the rules will be penalized as follows:

1<sup>st</sup> offence: a penalty of €250.00 2<sup>nd</sup> offence: a 5-minute penalty 3<sup>rd</sup> offence: disqualification

#### iv. Competitor's safety

All participating vehicles must carry the red triangle which, in the event of the vehicle stopping during a Special Classification Race, must be placed by a member of the team, visibly, at least 50 metres behind the vehicle, in order to warn the following drivers.

The team that fails to comply with this rule will be given a monetary penalty at the discretion of the Stewards.

In the event of an accident in which there are no injuries requiring immediate medical assistance, the OK sign (A3) must be clearly shown by a member of the participating team to the next three participating vehicles. If the team leaves the vehicle, they must leave the OK sign so that it is visible to the other participants. If you need urgent medical assistance, you must display the SOS, if possible, to the following vehicles. The team that fails to comply with this rule will be given a penalty, at the discretion of the Stewards, in accordance with the International Sporting Code.

#### v. Accident information

Accident involving a member of the public.

If a driver taking part in the Rally is involved in an accident in which a member of the public is injured, they must report it as specified in the route booklet.

The laws of the country regarding accident procedures must also be respected.

## **Accident enquiry**

Any accident that results in serious or fatal injuries will be reported to the FPAK Board, which will in turn inform the FIA - International Automobile Federation.

## vi. Penalties

Any other non-compliance with these regulations (Private Race Regulations) will be reported by the Race Officials to the CCD, which will decide on the penalty to be applied in accordance with Article 12 of the CDI.
