Reminder:

1. The entry and entry fee payment closing date for Round 9 was 10 October 2025 (midnight), and the Official Entry list will be published on Monday, 13 October 2025 via Sportivity.
2. The maximum number of starters in the event, including the support race, cannot exceed 140 (Art. 7.3.4 of the Sporting Regulations).
3. Acceptance of entries will be decided by each organiser, but priority will be given by category, and entries will be selected and validated according to the order of priorities listed in Art. 7.1.5 of the Sporting Regulations.
4. The Organising Committee reserves the right to refuse the entry of a Competitor or a Driver, giving the reason for such refusal, with respect of priorities specified in Art. 7.1.5. of the Sporting Regulations (Art. 7.3.1 of the Sporting Regulations).
5. The priorities indicated in the "Priority" column are reviewed on 13 October 2025, following the results of Round 9 in Mollerussa.
