4.4. Entry fees:

The entry fees are:

- 370€ when paid until the first closing date of the entries.
- 570€ when is paid after the first closing date of the entries but at latest on the last closing date the entries.
- 200€ for the Autocross and Cross Car Manufacturers' Cup until the latest closing date of the entries.

Entry fees include any costs related to use of electricity and water at the Competition. As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, must apologize giving the reason as soon as possible.

4.5. Entry fees refund:

The entry fees may be refunded only:

- To candidates who are not accepted.
- In the case of the Competition not taking place.
- If the Competitor announce to the organiser the withdrawal of his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, only 50% of the entry fee will be refunded.

For all cars, a limit of 100 dB is imposed.

The prizes will be awarded in Euros. Prize fund net of taxes distributed as per Article 15.2.2 of the Sporting Regulations.

10.1. Competitors' Liaison Officer (CLO):

10.2. Official Press Interview:

The three drivers classified first, second, and third in each final are required to attend and actively participate in the official press interview. Attendance and participation shall be mandatory and conducted in accordance with the instructions provided by the Race Director during the drivers' briefing, as well as any additional guidelines or communications issued through the official channels of the organiser.

Failure to comply with this obligation may result in penalties as set out in these regulations.
