The Porsche Sprint Challenge Southern Europe 2026, herein after called the Series, is organised in conformity with the provisions of the International Sporting Code and its appendices (the Code), and the National Sporting Regulations of the RFEDA and FPAK. It will be run in conformity with these Sporting and Technical regulations, the FIA Appendix J (Art. 277), the Code of driving conduct.

The Series will be run according to the above regulations. For the avoidance of doubt, should there be any inconsistency or conflict between the individual sets of regulations, then the order of priority shall be firstly those of the International Sporting Code, then the Porsche Sprint Challenge Southern Europe Regulations, followed by the RFEDA and FPAK Regulations and thereafter the Supplementary Regulations.
