12.7 Special procedures - Rally2

Rally2 will be according to Art. 46 of 2020 FIA Regional Rallies Sporting Regulations – V1 European Rally Trophy 2020 and Art. 21 of FPAK's Rally Specific Prescriptions.

Whenever a competitor gives up or is disqualified for an excessive amount of time (cf. Art. 18.5) on the 1st day of a 2-day competition, he is automatically entered into Rally 2. If, perhaps, he understands not to participate, he must inform the Director Race until 60 minutes before the departure time of the first car in competition of the rally in which it is inserted. Otherwise, a fine of € 1,000 (one thousand euros) will be applied by the CCD.

Up to 60 minutes before the departure time of the first car in competition for the rally in which it is inserted in this stage, you must place the car in a closed park. You need to obtain the favourable opinion of the DT regarding the security organs and new seals, if necessary.

The penalties to be attributed will be:

- a) the worst time in normal conditions is attributed, by vehicles of the same class, in the PEC where it gives up and in the following ones not travelled, plus 3 minutes each;
- b) not completing the last connection sector, 5 minutes of penalty;
- c) if the competitor has been disqualified for excessive time, the penalty to be attributed is that of the accumulated time that gave rise to the disqualification;

APPENDIX 4 - Identification and Advertising

- A Competition number two (2) competition numbers 14cm with a 2cm wide trace two (2) decals Serras de Fafe 67x17cm, for both front doors, with the number always positioned on the front.
- B Competition number two (2) competition numbers, one for each rear window, 25cm high with a 2cm wide trace.
- C Front plate one (1) front plate placed on the bonnet, 43x21.5cm
- **D** Competition number one (1) competition number, 14 high with 2cm wide trace and a decal Serras de Fafe (30x10cm) placed on the rear window.
- **E** two (2) advertising panels Fafe Município & CUCP 67x17cm to be on the front doors. (without optional advertising, it has to be paid 100% of the entry fee value)
