**5.1** For reasons of operational and safety necessity the time limit for the presentation of protests during the heats will be amended from 30 minutes to 15 minutes. Any protest must therefore be presented in writing to the Clerk of the Course or to his deputy within 15 minutes after the posting of the results of the Qualifying Practice and Qualifying Heats.

**5.2** The time limit for presentation of protests during the final phase remains unchanged. That is, within 30 minutes after the posting of the classification of the races of the final phase.

## ARTICLE 7 – SUPPLEMENTARY CONDITIONS

**7.1** The circuit will be closed for any track activity to all competition karts and Drivers from Friday the 4<sup>th</sup> December until Tuesday, the 8<sup>th</sup> December.

Free Practice sessions on Tuesday(8<sup>th</sup>) and Wednesday (9<sup>th</sup>) are only open to Drivers who have entered the Competition.

**7.2** Paddock installation will be allowed only on Sunday, the 6<sup>th</sup> December (9:00/12:00 – 13:00/19:00) and on Monday, the 7<sup>th</sup> December (8:00/12:00 – 13:00/20:00) and it will be carried out under the responsibility of the Organizer/Promotor for all Entrants who have registered

for the Competition. Attendees, including truck drivers and team staff, are only allowed to enter the paddock for the first time without a negative COVID-19 test not older than 96 hours.

**7.3** Sporting Checks and Scrutineering will be performed on Tuesday, and Wednesday morning. Passes will be issued at the main entrance on the Attendees Accreditation Office.

**7.4** It is strictly forbidden to smoke or to use any device which risks provoking fire in the Paddock area, the Servicing Parks, the Parc Ferme, the Assembly Area, on the starting grid or on the track (along the course). Offenders, including Officials, will be penalized by a fine of 125 € and may be asked to leave the circuit. A special area for welding and a "smoking" zone will be provided by the organizer. It is forbidden to cook in the Paddock, except with a special authorization from the Organizer.

**7.5** Children under 11 years old who are not permanently accompanied will not be admitted in the Paddock Area. Animals who are not kept on a leash will not be authorized on the location.

**7.6** For safety reasons the paddock will close at 19:30 and it is forbidden to stay in the paddock after this time.

## **ARTICLE 8 – COVID-19 COMPETITION GUIDELINES**
